## What is unique about the AUMFT Program?

### Student Focused Program

Student-centered education is our top priority. We provide expert faculty guidance, paid placement sites, a diverse clientele, cutting-edge curriculum, and abundant research opportunities.

- Our program has 3 faculty members and 12 students (6 students per cohort).
- Our MFT Cohorts take National Licensure Exam at the end of their time in the program.
- Our job placement rate in the MFT field has been among the best in the nation since 2007.

### Financial Aid

• Since 1985, ALL students have received in-state and out-of-state tuition waivers as incoming students.

### Internships

• Since 1998, all Auburn University MFT students have been offered paid internships.

## **Clinical Training**

- Across the last 25 years all students have earned an average of 100 couple therapy hours.
- All therapists complete between 500-700 therapy hours, and receive 100-250 hours of supervision, of which 50-150 hours are directly observed.
- We track client changes over time. Students demonstrate a strong alliance and client improvement.

The Auburn University Marriage and Family program mission is to enhance human well-being and quality of life worldwide through the training of multi-culturally informed marriage and family therapists. Our program was first accredited by the Commission on Accreditation for Marriage and Family Therapy Education (COAMFTE) in 1979. Since then, our program has evolved as a pillar of one of the top Human Development and Family Studies departments in the nation. For two decades, our graduating students pursuing doctoral education have enjoyed a nearperfect placement rate.

## Thesis Projects

The completion of a thesis is part of our rigorous curriculum. Students learn to develop their writing and research skills, then complete either a clinically or non-clinically focused project. These skills translate into masterful practical knowledge that advances our graduates in professional and research careers.
